CALLING FOR APPLICATION FOR THE POSTS OF DEPUTY CHIEF LEGAL AID DEFENSE COUNSEL AND FOR ENGAGEMENT AS FULL TIME LEGAL AID LAWYERS IN LEGAL AID DEFENSE COUNSEL OFFICE

LAST DATE FOR RECEIPT OF APPLICATIONS: 25/10/2025

As per the Legal Aid Defense Counsel System – Modified Scheme 2022 formulated by National Legal Services Authority, for providing legal aid, assistance and representation in criminal matters in line with "Public Defender System", the Karnataka State Legal Services Authority has established 30 LADCS offices in a phase wise manner. As per the directions of NALSA, optimum human resources have to be maintained at each LADCS offices in the state.

1. The scope of work:

Legal Aid Defense Counsel Office shall be dealing exclusively with legal aided matter in criminal matters of the District Head Quarters, wherein it is established. The Counsel appointed shall involve full time with the system and they are not allowed to take any private cases or any other retainership. The Legal Aid Defense Counsels are required to scrupulously perform the work profiles and follow the code of ethics as enumerated in the "Legal Aid Defense Counsel System-Modified Scheme-2022".

The following end to end legal services shall be provided through the Legal Aid Defense Counsel Office:

- Legal Advice and Assistance to all individuals visiting the office,
- Representation/Conducting trial and appeals including all miscellaneous work in all Sessions, Special and Magistrate Courts including executive courts.
- Handling Remand and Bail Work
- Providing Legal Assistance at pre-arrest stage as per NALSA's scheme for providing such assistance
- o Any other legal aided work related to District Courts or as assigned by the Secretary, DLSA.

2. Vacancy of Posts:

As per the directions of Hon'ble Executive Chairman, KSLSA, on the basis of pendency of criminal cases and legal aid cases, the following posts which falls vacant in respective DLSAs needs to be filled up on contract basis for a period of one year on monthly salary, with a stipulation of extension on yearly basis upon satisfactory performance.

As per the Legal Aid Defense Counsel Modified Scheme, 2022 there is a note with regard to increase or decrease of posts are per their requirements in individual districts. The note is reads as under.

"Note: Number of Deputy and Assistant Legal Aid Defense Counsel may be increased or decreased as per the requirement in individual districts. Number of Legal Aid Defense Counsels shall be proportionate to the actual requirement."

Hon'ble Executive Chairperson, KSLSA has accorded permission to increase and decrease the posts based on the pendency of cases in the respective districts. Accordingly, vacant posts from Districts which have less pendency of criminal cases are decreased and such posts are assigned/increased to the districts which have more pendency of cases.

Based on the pendency of cases and requirement in individual districts, the following vacancy position has been prepared.
