New Mangalore Port Authority invites applications from eligible retired Officers at the level of HoD or above, from the Port Sector having expertise in implementation of Engineering Projects and Port Development related matters, to engage as Advisor (Technical) on contract, initially for a period of one year, extendable by another one year. The eligibility criteria and terms & conditions are as detailed below:

I. Eligibility Criteria:

Experience: Should have worked as Chief Engineer (Civil) or equivalent in the Port Sector or above level posts in field of Civil Engineering in any, of the Major Ports/Ministry of Ports, Shipping and Waterways (MoPSW)/other organization under MoPSW. 3. Age: Less than 62 years

II. Terms & Conditions:

1. Tenure of Engagement: The tenure of contract is for a period of 01 year from the date of deployment (likely by first week of December 2025) which may be extended by another one year based on the performance of the candidate and requirement of the engagement.
2. Emoluments:
 - i) A fixed consolidated remuneration per month arrived at by deducting the basic pension from the last pay drawn at the time of retirement as per OM No.3-25/2020-E.IIIA, GoI, Ministry of Finance Department of Expenditure dated.09.12.2020 shall be admissible and no other service benefits will be admissible during the contract period.
 - ii) TDS as applicable will be deducted from the consolidated remuneration as per the extant Rules /Act.
 - iii) The amount of remuneration so fixed shall remain unchanged for the term of the contract.
 - iv) The remuneration will be paid as per the attendance recorded. Absence without leave will be treated as "no work, no pay" and accordingly, a proportionate amount will be deducted from monthly remuneration.
 - v) Facilities such as transportation, accommodation at NMPA quarters, laptop, mobile phone, mobile plan charges, TA/DA on tour etc. will be allowed as applicable to HoD level officers.

3. Job Role and Responsibilities: As an Advisor (Technical) to the Port, he shall extend technical support to all ongoing and future projects. He shall coordinate with Ministry of Ports, Shipping and Waterways, other Ministries, Niti Ayog, State Government, and other authorities for obtaining necessary approvals/NOC for implementation of various projects. He shall monitor the progress of important projects.
4. Hours of work: The selected candidate shall be required to work during the normal working hours and such extended hours as necessary for the proper discharge of duties. The selected candidate is also expected to work for additional hours depending on the necessity and urgency of work, for which no additional remuneration will be paid. The selected candidate is required to attend work on weekly off days/holidays if exigencies of work arise, for which no additional remuneration will be paid.
5. Leave/Holidays: 15 days Casual leave in a year with the prior permission of the Chairperson.
6. Termination of Contract: NMPA reserves the right to terminate the contract appointment at any point of time giving one month's notice without any liability. In the event of misconduct, the contract appointment can be terminated by the Port without any notice and without assigning any reason. In case the candidate wishes to leave the contract appointment at NMPA he/she is required to give a three (3) months advance notice in writing.
7. Settlement of disputes: In the event of any dispute arising out of during the contract period, the interpretation and decision of the Chairperson, NMPA will be final and binding. Further, the court of justification for any dispute will be at Mangalore only.

Interested & eligible candidates may submit their applications in the prescribed form available at NMPA and IPA websites along with the self-certified copies of certificates/documents in support of essential qualifications & experience. The applicant shall be a retired officer on the date of deployment in the Port as per Sl.No.1 above.
